The COMMENT REVIEW UPDATE

- The review of the Canadian Organic Standards is underway. During the 90-day public review of the updated draft of the standards, 706 comments were received. Each is being analyzed in a standardized, transparent manner. The Chair of the Working Group first proposes a resolution for each comment (all listed on Google docs and accessible by all Working Group members). Then, by teleconference, the Working Group discusses the proposed resolution and develops, through consensus, a response to the comment.
- The Chairs of the Working Groups are Karen Murchison and Jean Duval for Crop production (32.310 and 32.311 respectively), François Labelle for Livestock production (32.310 and 32.311), Rochelle Eisen for sections 1, 2, 3, 8 and 9 of 32.310, and Tables 6.3 to 8.3 in the Permitted Substances Lists. Janet Wallace is acting as the Working Group secretary. Nicole Boudreau is responsible for coordination of the review, translation and final preparation of the documents that will be submitted to the Technical Committee. Hugh Martin, the Chair of the Technical Committee, is actively involved in the comment analysis.

- Of the 706 comments received, 35% are editorial; 65% are technical, meaning that they relate to a technical or practical aspect of a clause. The Working Groups are only discussing comments that relate to the proposed changes to the standards.
- The resolutions to the comments will be presented to the voting members of the Technical Committee before the ballot. The committee members need to understand the justification for maintaining, altering or canceling a proposed modification to the 2015 standards.
- Given the large number of comments, the Technical Committee will need to meet twice by teleconference -- December 18, 2019 and in 2020. The second meeting will focus on the proposed modifications to the Livestock section (32.310 and 32.311).
- The exercise of resolving comments may lead to the complete reversal of some of the proposed modifications presented for public comment. A report will be presented on InfoBio after the first meeting of the Technical Committee.
