Standards Interpretation Committee – New Comment Period

Questions and Answers on issues related to the Canadian Organic Standards

Are herbicidal soaps allowed under the Standard? When calculating summer ration for ruminants, can pasture be considered "long-fiber forage"? Revised answer to the following question: Can conventional straw be used as a compost feedstock for compost that is used to grow organic mushrooms?

The Review of the Canadian Organic Standards

The CGSB Committee on Organic Agriculture (Technical Committee) will meet in Gatineau on December 11-13 for the first meeting of the Canadian Organic Standards Review.

During October and November, twenty-three meetings of the six main Working Groups were held to prepare the 116 recommendations that will be discussed by the Technical Committee members.

The CGSB has reestablished the Technical Committee, with an aim of having a balance of producers, users, regulators and general interest members, such that one group cannot out-vote other members or dominate the proceedings. The Technical Committee has approximately 100 members (including voting members, alternates and 'information' [non-voting] members). Of these 100 members, 43 are voting members, responsible for the technical content, approval and maintenance of the standards. The current list of voting members can <u>be reviewed here</u>.

At the COS review, we have to discuss about.... Substances grown on GE substrates



Some substances are grown on GE substrate, and there is no residue of this GE substrate in the final product.

But 1.4.1 states that use of GE is not compatible with organic principles. Would the total prohibition of GE result in losing access to many important crop inputs? Substances grown on GE Soy substrate: bacillus subtilis, yeasts, yoghurt & cheese cultures, microbials such as rhyzobium, compost starters, enzymes, riboflavin, antibiotics & vaccines. Should the problem of commercial availability be considered as a serious concern?
