Vote on moratorium on approval of GE alfalfa to be held March 22nd

The <u>meeting held March 10th</u> at the Standing Committee on Agriculture and Agrifood to vote for a motion requiring a moratorium on approval of GE alfalfa until public reseach is completed has ended before a vote could be cast on that important motion for the organic sector.

The Standing Committee on Agriculture and Agrifood will meet again <u>Tuesday March 22nd</u> to continue debating the motion on GE alfalfa, unless the government launches elections before that date.

The use of biotechnology is contentious within the Canadian agricultural sector: the Canadian Organic Standards prohibit the use of GM seeds and substances derived from GE manipulations. The Organic Value Chain Round Table Meets in Winnipeg

The Organic Value Chain Round Table (OVCRT) met in Quebec City on June 28-29, 2010, and there will be an upcoming OVCRT meeting in Winnipeg on March 22-23, 2011.

The Bulletin of the Quebec Meeting, now available on the <u>AAFC website</u>, reports on the research currently being undertaken, such as:

- The <u>Carbon Footprint Study</u> which had a goal of determining if sufficient evidence exists to substantiate organic product differentiation claims, based on its carbon footprint. The report states that organic products can be differentiated on its low carbon footprint.
- In addition, the following studies are currently in progress:

• **The Organic Seed Study**, which has an objective of "assessing the current and potential organic seed markets in Canada, identify barriers to the development of the organic seed sector, and provide recommendations on how to structure and develop the Canadian organic seed sector";

The GMO Study, which has an objective of "assessing the agronomic and economic impacts of GMO contamination and explore solutions to address the issues while maintaining the long term sustainability of the organic sector".

Next version of the Canadian Organic Standards Published in April

The CGSB is planning to post in April the revised version of the Organic Production Systems Standards following the meeting held in January 2010 in Cornwall.
